
How far in advance do you require notification that you have been selected to deliver an EPA?



Do AOs consider that the availability of assessors impacts on the timely delivery of assessments?





88% of all respondents said they had previously delivered training.







How many AOs do you regularly work with in the capacity of an EPA assessor?








Reasons for Satisfaction/Dissatisfaction


How satisfied are you with the length of time it takes the Awarding Organisation to do the following?









Only time intervals of less than 500 days are included





Timeliness by standard: (top 10 standards)


Time from completion of learning activities till the first EPA assessment






Scope and scale





- Risk 1: AOs planning and having sufficient resources in place for delivering EPA
- Risk 2: Effective and efficient decisions on Gateway once the provider had submitted the apprentice as ready for Gateway
- Risk 3: Effective and efficient delivery of EPA once Gateway had been passed.

Thematic findings



- Good levels of assurance across all three risks and with all AOs
- Variety of means to forecast
- Range of controls to help apprentices move through gateway
- Apprentice personal circumstances feature heavily in delays


